

Clay County Schools Reimagined Time & Snow Packets

We have posted a section of our Reimagined Time Policy to clarify when the Snow Packets kick in for Clay County Schools. Our first Reimagined Time day was originally scheduled for our 9th day of school missed. Since we did not miss any days prior to Christmas break, we will schedule our first Reimagined Time day for our 7th day of school missed. We have to exhaust our OS days plus 2 additional days before we begin using the snow packets. Currently, we will have to miss four more days before the Snow Packets come into play. Please refer to the chart below from the policy. The policy is designed not to eliminate all makeup days but rather to avoid going to school late in June like we did in 2015-2016. The state board will not allow us to start prior to our 9th day out.

Clay County plans to address reimagined time instructional time/instructional day by using the outside school environment (OS) days in Clay County Schools' 2016-2017 school calendar. These OS days will be converted to instructional days first to make up days where school has been called off due to inclement weather conditions or other extenuating factors (i.e. power outages, flooding, lack of water, etc.). Clay County has six OS days that can be converted into instructional make up days. Clay County Schools can also convert the June 1, 2017 Continuing Education Day (CE) and the June 5, 2017 Preparation for Closing Day (P) into instructional days. Clay County Schools intends to utilize 'Snow Learning Packets' composed of developmentally appropriate programmatic level and grade level content to provide up to five days instructional time. The 'Snow Learning Packets' will replace school attendance for all Clay County Students for unplanned school closures (due to inclement weather conditions or other extenuating factors detailed above) only for Day 9, Day 10, Day 11, Day 12 and Day 13. The 'Snow Learning Packets' will incorporate an average minimum of five hours of instructional time per day but not to exceed 315 minutes at the elementary level, 330 minutes at the middle school level and 345 minutes at the high school level. The Reimagined Time will occur in a learning environment outside of the school. The learning environment may be the students' home, day care, Clay County Public Library, etc.

The schedule of implementation will be as follows:
